

Sub-divide a water access licence 71P(a)



Under the *Water Management Act 2000*, a water access licence can be sub-divided, by cancelling a water access licence and creating two or more new water access licences in its place. Limited aspects of the licences created through sub-division can be changed – those which cannot are outlined below.

When might this dealing be used?

A water access licence might be sub-divided to facilitate a water trade and/or to change one or more of the licences in preparation for sale.

Any holder can apply to sub-divide or sub-divide and change a water access licence. Sub-division cannot be restricted by a water sharing plan.

Limitations to keep in mind.

There are some limitations to sub-divide or sub-divide and change dealings. Water access licences arising from sub-division can only be granted:

- In the same water management area or water source as the original water access licence/s.
- With combined share and extraction components not more than the original water access licence.
- With the same mandatory conditions as the original water access licence.
- For a period not greater than the period for which the original water access licence would have had effect if it had not been cancelled.
- For the same category or sub-category as the original water access licence.
- Water allocation remaining in the original licence is credited to the new water access licence/s on cancellation of the original.

Additional limitations may apply to nominations of water supply works for licences created by subdivision in the Lower Murrumbidgee Groundwater Sources Local Management Areas.

Sub-dividing a water access licence **does not** increase the amount of water; change share and/or extraction components; change conditions that apply; change

the water source/water management area or the category or sub-category; or increase the period the licence is granted for.

Some questions to consider

You need to be able to answer the following questions in sub-dividing a water access licence:

- How will the share component be divided?
- Are [additional nominated works](#) approvals to be added or removed from one or more of the sub-divided licences?
- Will the sub-divided licences be held in the same names and tenancy as the original water access licence? If any change of ownership is required, then a [71M Transfer form](#) should be lodged with NSW Land Registry Services by the applicant at the time the new water access licences are registered.
- How will the water allocation and, where applicable, the carryover water in the existing water account be distributed in the sub-divided licences' water accounts? Any excess may be forfeited - refer to the relevant water sharing plans account rules.

You must register the new water access licence/s with NSW Land Registry Service immediately. Impacts of delayed registrations on the distribution of account water include e.g. a new water year, and timing of available water determinations (AWD) should also be considered.

When is this dealing type prohibited?

The *Access Licence Dealing Principles Order 2004* prohibit dealings under s71P if the original licence is suspended.

How do I go about it?

To sub-divide a water access licence, or sub-divide and change nominated works for nominated works for a water access licence, use the [Application to sub-divide and change nominated works for a water access licence form](#). Remember to download the

[guide](#) to the form as well. You can also submit this application through [Water Applications Online](#).

Once approved, WaterNSW prepares a Notification form, and you lodge this AND the original water access licence certificate with NSW Land Registry Services **before the expiry date recorded on the Notification form.**

The new water access licence/s (and certificates) will show the same holders and tenancy arrangements as the original water access licence.

If you also wish to

- transfer one or more of the sub-divided licences to another holder or
- change ownership from, for example, three current holders to a single holder then you will also need to lodge a Transfer form.
