

Application - Assign share components between water access licences (71Q)

SECTION G – Privacy statement

However, if you choose not to provide the requested information, we will not be able to process your application. SECTION H – Offences and suspension or cancellation

It is an offence, under section 344 of the *Water Management Act 2000*, to make a statement that you know to be false or misleading in, or in connection with, this application. A Corporation found guilty of an offence against section 344 is liable to a penalty of \$2.002 million. An individual found guilty of an offence against section 344 is liable to a penalty not exceeding \$500,500. An approval and/or licence as applicable may be suspended or cancelled under the *Water Management Act 2000* in certain circumstances. These include if the holder of the approval is convicted of an offence under that Act.
