

Application for a search for water-related interests

Use this application form to request a search for water-related interests held under the *Water Act* 1912 and/or the *Water Management Act* 2000 (WM Act) associated with specific parcels of land which may be included in the sale of the land and therefore may be transferred on settlement.

Steps to apply

1. Complete the application form

Applicants are advised to read about searches for water-related interests on the <u>WaterNSW</u> <u>website</u>. This information will assist in completing the form, paying application fees and submitting the application.

2. Pay application fee

This form will not be processed until the application fee has been received by WaterNSW.

Application fees vary depending on the processing timeframe you require. If an application has been accepted by WaterNSW, payment has been processed and a receipt has been issued, application fees will not be refunded.

3. Submit the application form
