To satisfy Clause 244A of the Water Management (General) Regulation 2018, you must **report** your water take by the 14th day of the following month. This can be done using iWAS, our online reporting form or alternatively by submitting this form. Please submit a separate reading for each meter.

If you do not plan to take water, let us know by submitting the <u>CI 244 pause</u> water take form and you will not be required to report take during that period.
