

Application to subdivide, or to subdivide and change a water access licence

This application form should be used to:

- subdivide a water access licence (WAL) under section 71P (1) (a) of the *Water Management Act 2000* (the Act)
- subdivide a WAL under section 71P (1) (a) of the Act and change one or more of the new WALs.

Subdivision means the cancellation of a WAL and creation of two or more new WALs. The 'change' to one or more new WALs may relate to any of the following:

- conversion to a new category/ subcategory of WAL (under section 71O of the Act);
- amendment of the share component of a WAL, to specify a different water source/ water management area (under section 71R of the Act);
- amendment of the extraction component of a WAL, to vary the times, rates or circumstances with respect to the taking of water under the WAL, or to vary the areas or locations (e.g. zone/ sub-zone) as the areas or locations from which water may be taken under the WAL (under section 71S of the Act);
- add or remove a nominated water supply work (also applicable to intrastate and interstate tagging) (under section 71W of the Act).

If you wish to change a WAL without subdivision, use the application form *Application to change a water access licence*. If you intend to make any other types of changes to your WAL, you will need to complete a different application form.

Important note

Any subsequent transfer of subdivided licences, including transfer to a different combination of existing holders may have tax implications. You are encouraged to seek your own independent advice regarding any potential tax liability that may arise.

WAL holders are advised to read the guide to this form. Step-by-step instructions on each section are included in the guide, which also lists options for submitting this application and application fees. Information on fees is also available from the WaterNSW website www.waternsw.com.au.

Note: If an application has been accepted by WaterNSW, payment has been processed and a receipt has been issued, application fees will not be refunded.

Notes to E1

This is to apply under section 71O of the Act for the cancellation of the WAL and the grant of one or more new WALs of the category or subcategory specified in E1 above.

Notes to E2

This is to apply under section 71R of the Act for the cancellation of the WAL and the grant of one or more new WALs with a share component specifying a different water source or water management area as specified in E2 above.

Notes to E3

This is to apply under section 71S of the Act to amend the extraction component of the WAL (this may be to vary the times, rates or circumstances with respect to the taking of water under the WAL, or to vary the areas or locations from which water may be taken under the WAL, which may include specifying a different zone or sub- zone), as specified in E3 above.

Notes to E4

This is to apply under section 71W of the Act to amend the WAL to:

- add the water supply work / group of water supply works specified in E4 above, as a work / group of works by means of which water allocations under the WAL may be taken; or
- remove the water supply work / group of water supply works specified in E4 above, as a work / group of works by means of which water allocations under the WAL may be taken.

In E4, insert the number of the water supply work approval/s for the water supply work/s to be added or removed. For approval/s with more than one water supply work, you will be adding or removing all water supply works that are listed on the approval.

For a water supply work/s which is located in an interstate water tagging zone, you need to:

- insert the State and the interstate licence number (eg Victoria – allocation bank account, South Australia – entitlement, Queensland – Development Permit); and
- attach the completed form/s, as required by the interstate agency (the 'State of Destination' forms), to this application. Please note that the State of Destination form/s comprise an essential component of this application. Note: Queensland does not require the completion of a 'State of Destination' form, however, the applicant must supply a copy of the current Development Permit and a Works/ Meter Verification Notice endorsed by the 'State of Destination'.

Important

Interstate water tagging protocols to the Murray Darling Basin Agreement provide that a WAL can only nominate one interstate water tagging zone. If a work in an interstate water tagging zone is added to the WAL, any works in another interstate water tagging zone will be removed from the WAL. This limitation does not apply in relation to interstate water tagging between New South Wales and Queensland.

- d) that all information contained in this application is accurate, true and complete and that the State will rely on such information

- e) that the State does not provide any legal, financial or technical advice in connection with this application and that any such advice, if required, is to be obtained independently
- f) that details about any subdivision and or subdivision and change to a water access licence arising out of this application will be recorded in the publicly available Water Access Licence Register, pursuant to the *Water Management Act 2000*.

Privacy note

The personal information you provide in this form will be treated in accordance with the Privacy and Personal Information Protection Act 1998, under which you have rights of access and correction. Your personal information will be used for assessing and processing your application or in connection with the operation of any WAL granted and may be disclosed to State or Commonwealth public authorities and other parties: (i) for any of the above mentioned purposes; or (ii) for research related purposes; or (iii) as required by law. If a WAL is granted, the *Water Management Act 2000* requires that various details relating to the WAL are to be recorded in the Water Access Licence Register kept by the Minister. Information recorded in the Water Access Licence Register is publicly available.

Offences and suspension or cancellation

It is an offence, under section 344 of the *Water Management Act 2000*, to make a statement that you know to be false or misleading in a material particular in, or in connection with, this application. A corporation found guilty of an offence against section 344 is liable to a penalty not exceeding \$1.1 million. An individual found guilty of an offence against section 344 is liable to a penalty not exceeding \$247,500.

A WAL may be suspended or cancelled, under section 78 of the *Water Management Act 2000*, if: (a) the holder of the licence has failed to comply with any term or condition to which the licence is subject, (b) the holder of the licence has been convicted of an offence against the Act or the regulations, (c) if any fees, charges or civil penalties in respect of the licence have not been paid, whether or not those fees, charges or civil penalties were incurred by the current holder of the licence, (d) the holder of the licence has failed to comply with any direction given to the holder under this Act in connection with the licence, or (e) the licence was granted as a result of false, misleading or materially inaccurate information supplied by or on behalf of the applicant.
