

Report monthly licensed water take without telemetry

To satisfy Clause 244A of the Water Management (General) Regulation 2018, you must report your water take by the 14th day of the following month. Please submit a separate reading for each meter.

If you do not plan to take water, let us know by submitting the [No-take notice](#) and you will not be required to report usage during that period.

Please note: This form is to only be used by customers who have a meter installed without telemetry. If you are yet to have a meter installed, you are required to use the annual recording form. If you use the [annual recording form](#), this does not negate your responsibility to also comply with your metering requirements.

It is being collected by WaterNSW and will be used for purposes relating to your condition requirement to record and report your licensed water take in line with the applicable monitoring, recording, and reporting Water Management (General) Regulation 2018 clause(s).

WaterNSW will not disclose your personal information to anybody else unless authorised by law. You have the right to request access to, and correct details of, your personal information held by WaterNSW. Monitoring, recording, and reporting conditions applicable to water licences require some personal information in compliance with the relevant legislation and to provide you with our services. If you choose not to provide the requested information in this form, required for compliance with your licence conditions and to provide you with our services, you may not be able to take water as your licence may be suspended or cancelled, and, more generally, you may be in breach of the *Water Management Act 2000*. Offences and penalties

It is an offence, under section 344 of the *Water Management Act 2000*, to make a statement that you know to be false or misleading in, or in connection with, this application. A corporation found guilty of an offence against section 344 is liable to a penalty not exceeding \$2.002 million. An individual found guilty of an offence against section 344 is liable to a penalty not exceeding \$500,500. An access licence or approval may be suspended or cancelled under the *Water Management Act 2000* in certain circumstances. These include if the holder of the licence or approval is convicted of an offence under that Act.
