

Floodplain harvesting measurement recording and reporting form

This form is to be used when using secondary measurement equipment or when you are unable to log in to our Online Water Accounting System (iWAS).

What you need to do

This form is to be used to record floodplain harvesting water taken under a floodplain harvesting access licence with compliant secondary metering equipment. You will need to submit a separate form for each storage. This form is also to be used by customers who are compliant with floodplain harvesting regulations but are unable to access iWAS.

You have the right to request access to, and correct details of, your personal information held by WaterNSW. Monitoring, recording and reporting conditions applicable to water licences require some personal information in compliance with the relevant legislation and to provide you with our services. If you choose not to provide the requested information in this form, required for compliance with your licence conditions and to provide you with our services, you may not be able to take water as your licence may be suspended or cancelled, and, more generally, you may be in breach of the *Water Management Act 2000*.
